Position Title: Financial Aid Specialist 1

FLSA Status: Non-Exempt Salary Grade: 02

#### **Position Summary:**

The Financial Aid Specialist 1 provides extensive financial aid services to students, families, and the community. Delivers financial aid outreach sessions to explain the different sources of aid related to the different programs of study that the College offers. Explains financial aid processes, completion, and submission. Interprets financial aid regulations for students and their families.

#### **Essential Duties and Responsibilities:**

Examples of key duties are interpreted as being descriptive and not restrictive in nature. Incumbents routinely perform approximately 80% of the duties below.

- 1. Develops and presents effective outreach and recruitment programs for available student financial aid programs and services; prepares and updates related outreach and application materials.
- 2. Provides information and assistance to faculty, staff, students, and the public regarding application procedures, opportunities, and eligibility requirements for student financial aid.
- 3. Coordinates and organizes assigned projects, analyzes problems, and determines the appropriate course of action using discretion and initiative based on guidelines and procedures.
- **4.** Researches, compiles, analyzes, and summarizes data and prepares a variety of statistical reports; gathers, compiles, and analyzes data; and prepares information in written and oral format.
- 5. Works with supervisors, administrators, and other staff to communicate applicable federal, state, and district policies, and procedures.
- 6. Serves as program resource for developing student financial aid objectives, goals, and procedures.
- 7. Maintains department calendars and coordinates meetings; prepares meeting agendas and minutes.
- 8. Performs all other duties and responsibilities as assigned or directed by the supervisor.

## Knowledge, Skills, and Abilities:

- 1. Knowledge of regulatory compliance principles and practices.
- 2. Knowledge of administrative procedures and practices.
- 3. Knowledge of internal and external customer service principles and practices.
- 4. Knowledge of principles and methods for promoting programs and services.

- 5. Skill in analyzing data and drawing conclusions.
- 6. Skill in organization, coordination, and management.
- 7. Skill in public speaking
- 8. Ability to apply analytical and critical thinking skills as well as draw conclusions and prepare accurate reports of results.
- 9. Ability to apply effective and accurate data entry and typing skills.

#### **Minimum Qualifications:**

- Associate's degree in Business, Administration or a closely related field of study preferred.
- One (1) to three (3) years of related experience with financial aid.
- National Association of Student Financial Aid Administrators (NASFAA) Certification preferred.

OR An equivalent combination of certification, education and experience sufficient to successfully perform the essential duties of the job such as those listed above.

### **Physical Demands:**

- **Environment:** Work is performed primarily in a standard office environment with staff contact and frequent interruptions.
