#### 1. Introductions (10 minutes)

- a. Welcome to all Interim Chancellor Dr. Dolores Duran-Cerda
- b. Welcome from the Acting Provost: Dr. Jeff Theis The Acting Dean of College Readiness and Student Success position will open this fall. Vice President of Academic Affairs will also be filled soon to replace Lamata Mitchell.

Rita responded that All College Day has typically been planned by the Chancellor's office and All Faculty Day is planned by faculty so this may be why faculty are not included at this time.
- e. Rita Lennon read a message from the chat box concerning the use of water bottles and balloons at All College Day in regard to our sustainability goals.
- f. Tiffany Amorette mentioned that sustainability is an important topic of focus this year and we need to think globally and act locally.

- g. Virtual participation was limited to no comments this year. It is requested that commenting ability be brought back.
- h. Kate Schmidt stated that Dr. Duran-Cerda would ensure an All College Day survey be sent out.
- i. Maggie Golston stated she is not sure that having a consultant group search for our next Chancellor is the best way to approach this search.
- j. Makyla Hays mentioned that the Board of Governors approved Dr. Dolores Duran-Cerda as our Interim Chancellor to cut out one consulting firm to find an Acting Chancellor.
- k. Kelly O'Keefe mentioned that with a Culture of Caring message from our Interim Chancellor, Online Instructors need to make extended efforts to show we are here for the online students and that we care for them as well.
