Pima Community College signed and submitted to the Department of Education the Certification and Agreement on April 10, 2020, to provide Emergency Financial Aid Grants to students. Pima Community College received notice of allocation of HEERF funds for providing emergency financial aid grants to students on April 20, 2020.

Pima Community College signed and submitted to the Department of Education the Certification and Agreement for the Institutional Portion of the Higher Education Emergency Relief Fund on April 23, 2020.

Pima Community College signed and submitted to the Department of Education the Certification and Agreement for Minority Serving Institution of the Higher Education Emergency Relief Fund on May 5, 2020.

As part of the requirements of receiving funds under Section 18004(a)(1) of the CARES Act, the college is required to provide periodic reporting. The first report is due within 30 days of the notice of allocation. Subsequent updates related to this provision are due every 45 days thereafter.

Reporting requirements include:

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

Pima Community College submitted the Certification and Agreement form on April 10, 2020, documenting the college's assurance that the college would be using no less than 50% of the CARES Act funding for Emergency Financial Aid Grants to students. The college received a notification that the grant was awarded and funds were available on April 20, 2020.

 - B. Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA, also known as HEERF 2). Pima Community College received \$4,994,525 to distribute to students, March 2021.
 - C. American Rescue Plan Act (ARPA, also known as HEERF 3). Pima Community College received \$19,906,024 to distribute to students, June 2021.

1) Students enrolled on March 13, 2020, or after.

- 2) Students that have completed a Free Application for Federal Financial Aid (FAFSA) or are eligible to complete the FAFSA. This is not a requirement for the distribution of ARPA (HEERF 3).
- 3) Students that meet the criteria specified in Section 484 of the Higher Education Act of 1965, as amended
- 4) If students otherwise met requirements, they were automatically selected and distributed funds in the tiered award amount based on enrollment level.
- 7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.

Notice of the Higher Education Emergency Relief Fund was sent through a variety of methods, including emails sent directly to students and placement on the college's portal and web site, social media posts, and the local newspapers.

Pima Community College received \$4,994,524 for the Institutional portion and \$640,155.00 for the MSI portion, April 2020. Pima Community College determined that \$1,500,000 of the institutional portion received to be distributed to students.
- E. Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA, also known as HEERF 2). Pima Community College received \$17,602,767 for the Institutional portion and \$1,242,857 for the MSI portion, March 2021.
- F. American Rescue Plan Act (ARPA, also known as HEERF 3). Pima Community College received \$18,783,571 for the Institutional portion, June 2021 and \$2,069,352.00 for the MSI portion, June 2021.

Technological Hardware and Internet Resources
